**Food Vendor Fee:** \$700 for 20'x20' space plus \$200\* security deposit (refundable)  
Discounted beer/wine sampling tickets are available to vendors for \$20 each (limit 2)

**Set-up Times:** 8/11/17 9:00 A.M. to 5:00 P.M.  
8/12/17 8:00 A.M. to 11:00 A.M.  
**You must have your vehicle unloaded and parked in vendor parking by 10:00 A.M.**  
**Your booth must be ready by 11:30 A.M. on August 12, 2017 (or before the Health Dept. Inspection)**  
**You must provide your own flame retardant tent(s) and generator/power.**

**Tear Down:** 8/12/17 7:05 P.M. (Vendors may not begin tear-down until close of festival)

\* **FOOD VENDORS** - A \$200 security deposit is required from all food vendors in addition to the vendor fee of \$700. Please write ONE check for \$900 payable to Kegs and Corks Festival. Security Deposits will be returned within 30 days after the event IF the vendor space is clean and found in its original condition. Please pickup all trash, discarded food and cigarettes. Please do not dump grease or gray water on the grounds. There will be gray water barrels available on-site for disposing any used water.

- After confirmation all food vendors must complete an Anne Arundel County application for a Temporary Food Special Events Permit (you can download the application at [www.aahealth.org](http://www.aahealth.org)). An application fee of \$195 applies. You must turn in a completed application in person or mail to the Anne Arundel County Department of Health, Division of Community & Environmental Health, 3 Harry S. Truman Parkway, Annapolis, MD 21401. If you have questions you can call 410.222.7363. Application should be submitted at least 3 weeks prior to the event to avoid late fees. Licensed mobile units do NOT have to obtain a Special Events Permit.
- Security will be provided 24 hours from 7 P.M. August 11 to 7 A.M. August 12. Merchandise left on grounds will be at owner's risk.
- Vendors will be given ONE parking pass for a designated parking lot after setup. No on-site camping permitted.
- Vendor assignments will be determined by the festival committee and posted at the festival registration table. Preferences and exclusivity will not be guaranteed.
- Vendor is responsible for reporting any and all sales tax collected. For more information visit [www.marylandtaxes.com](http://www.marylandtaxes.com).
- Vendor is responsible for their own display setup and equipment. For table and chair rentals, contact Ashlee at [ashlee@kegsandcorksfest.com](mailto:ashlee@kegsandcorksfest.com) (tables \$10 each and chairs \$3 each).
- Vendor must add Kegs and Corks Festival, LLC and Anne Arundel County Fair, Inc. as additionally insured for August 12, 2017 on your general liability policy and send a certificate of insurance to [ashlee@kegsandcorksfest.com](mailto:ashlee@kegsandcorksfest.com) at least one week before the event.
- A confirmation letter will be emailed or vendor's check will be refunded as confirmation of participation in the festival. This is a rain or shine event. No refunds will be given due to weather.
